Key dates may be changed or altered at the discretion of the Director or the Church. Any changes will be communicated as quickly as possible via email and social media channels.

Parental Expectations

Each year, we ask that you familiarize yourself and your child(ren) with the Code of Conduct and other policies contained in this handbook.

The Point extends opportunities for growth in your family's relationship with Jesus Christ as well as in academics and experience. It is the expectation that you will fulfill items such as transcript preparation and college/trade readiness within your personal homeschool journey. In addition, The Point co-op is unable to offer tutoring, IEP assistance, after-school care, or similar items.

As stated further in this handbook, volunteering is expected as part of the Co-op for each instruction day to run smoothly and safely.

In addition, parents of K-5th students are expected to always be on-campus or to have a responsible proxy adult available on campus if an emergency arises. Parents of 6th-12th students are requested to be on-campus but also can drop off for limited times if the need arises, as long as a responsible proxy adult is available if an emergency arises. The allowance of 6th-12th parents to be off campus may be revoked at any time at the discretion of the Director, Lead Pastor, or Elders, depending on need and/or behavior of the child(ren).

Please remember that anytime your child(ren) is not in class, they are to be with you.

The Banquet Room (adjacent to the FLC/Gym) is set up for quiet work and reasonable conversation, so others may homeschool or complete their employment work. Please make sure you are cleaning up after you and your child(ren).

Using an acronym helps our parents and students remember our basic rules and apply them more easily.

WORKS is derived from James 2:26, "For as the body without the spirit is dead, so faith without works is dead also." (KJV) Each portion of the acronym is also a Biblically-based character trait.

1. **Wisdom** is God's truth guiding your thoughts and actions and has Psalm 111:10 as the reference verse.
2. From John 14:21 comes **Obedience**, where we obey the first time, every time [with a happy heart!].
3. Be someone God and others can count on - **Responsibility** is part of Galatians 6:4-5.
4. To have a friend, you have to be a friend. **Kindness** is an integral part of this - guidance is found in Ephesians 4:32
5. Finally, **Self-Control** covers many aspects such as action, health, wellness, and thought, amongst others. Don't be "...like a city that is broken-down, and without walls" as Proverbs 25:28 cites.

Code of Conduct Violations

Although it is expected students will work to keep our Code of Conduct, there may be students not willing to follow this path. For these situations, the following guidelines are set forth for disciplinary action:

1. The student will be set apart from the classroom, and parents will be notified of misconduct.

The teacher will utilize the volunteer to help set the student apart. A student may be placed in a supervised location in the hallway or portion of the classroom.

2. A meeting with the parent(s), student, teacher, and Director will occur to discuss any continued misconduct.
3. If a student decides further steps are necessary, the student will be dismissed from The Point.

Social Media and Photography Policy

From time to time, we will take photos or videos to share or use on our website and social media.

It is understood that the parent(s)/guardian(s) gives Mt. Pleasant Church permission to use their child(ren)'s image. The parent(s)/guardians(s) also understand that no royalty, fee, or other compensation shall become payable by reason of such use. The parent(s)/guardians(s) understand that this permission does not expire.

If the parent(s)/guardians(s) wish to revoke this permission, they must notify the church via email to office@mtpleasant.church each new academic calendar semester or year.

This policy is also part of the registration form.

Volunteer Expectations

It is expected all parents will volunteer at times throughout the semester. Each family needs to sign up and fulfill at least 20 hours per semester.

Opportunities to help include, but are not limited to:

Check in, Pick up, Hall Assistants/Monitors, Security, Teacher's Assistants, Nursery (for teachers/volunteers needing this)

Clear and current background checks will be required and will be completed through Clear Investigative Advantage. If you have not completed a background check for a Mt. Pleasant Church event or ministry, you will receive an email from this organization to complete the background check.

If you are unable to volunteer due to extenuating circumstances, a volunteer opt-out fee may be discussed. If approved, a \$125 opt-out fee will be applied per semester applicable.

In addition, in our goal to have at least two adults in the classrooms at all times, we ask that a minimum of 20 spots be filled by each registering family.

Junior Volunteers

Trained older students may be allowed to help support co-op activities in volunteer roles. Let the co-op director know if you are interested in learning more. It will be totally at the discretion of the parent as to any school credit that will be awarded for Junior Volunteer service.

Complaint Resolution

From time to time, situations arise that cause disagreements within the body of the Co-op. The following complaint resolution process should be used:

1. **First Step** – In accordance with instructions in Matthew 18:15, the first attempt to handle conflict should be within the two parties.
2. **Second Step** – If the conflict is not resolved in accordance with Matthew 18:15, a complaint should be made in writing and brought to the Co-op Director.
3. **Third Step** – Complaints will be reviewed by the Co-op Director and addressed via phone call or email.
4. **Fourth Step** – If a resolution is not achieved, the complaint will be presented to the Homeschool Co-op Committee in an attempt to address the concerns. The Pastors, Deacon, and Elders will be notified.
5. **Fifth Step** – The Homeschool Co-op Committee will meet with the Co-op Director and the person rendering the complaint with the goal of resolution.
6. **Sixth Step** – If a resolution is not achieved, the complaint will be referred to the Pastors, Deacon, and Elders to help address it.

2025-2026 Tuition and Fees

Registration fees will be due each semester, Fall and Spring, and are payable upon registration. Individual class tuition and/or fees are due to the teacher directly and are to be paid before the first class.

Tuition and Material costs depend on the course and are due directly to the teacher.

Schedule Additions are \$10-20, depending on date completed according to Handbook policy (see Pg.11).

Add/Drop Policy

When you register your child(ren), The Point holds a spot for your child(ren), estimates costs according to your child(ren)'s attendance, and accepts this as your commitment to the Co-op.

We understand that extenuating circumstances require a class to be dropped or enrollment to be withdrawn at times. For this, the following refund tier should be followed:

Registration-Orientation	50% refund
Orientation-First Day of Class	25% refund, <i>Class Material Fees still applicable</i>
After the First Day of Class	0% refund, <i>Class Material Fees still applicable</i>

A withdrawal form should be used to complete this process. Please email the Co-op Director for this form.

Additions to the schedule may be made on a first-come, first-served, and space availability basis. The following rate tier should be followed:

Registration-Orientation	No Fee
Orientation-First Day of Class	\$10 fee per class
After First Day of Class	\$20 fee per class

** No additions to schedule may be made after the first week of classes **
